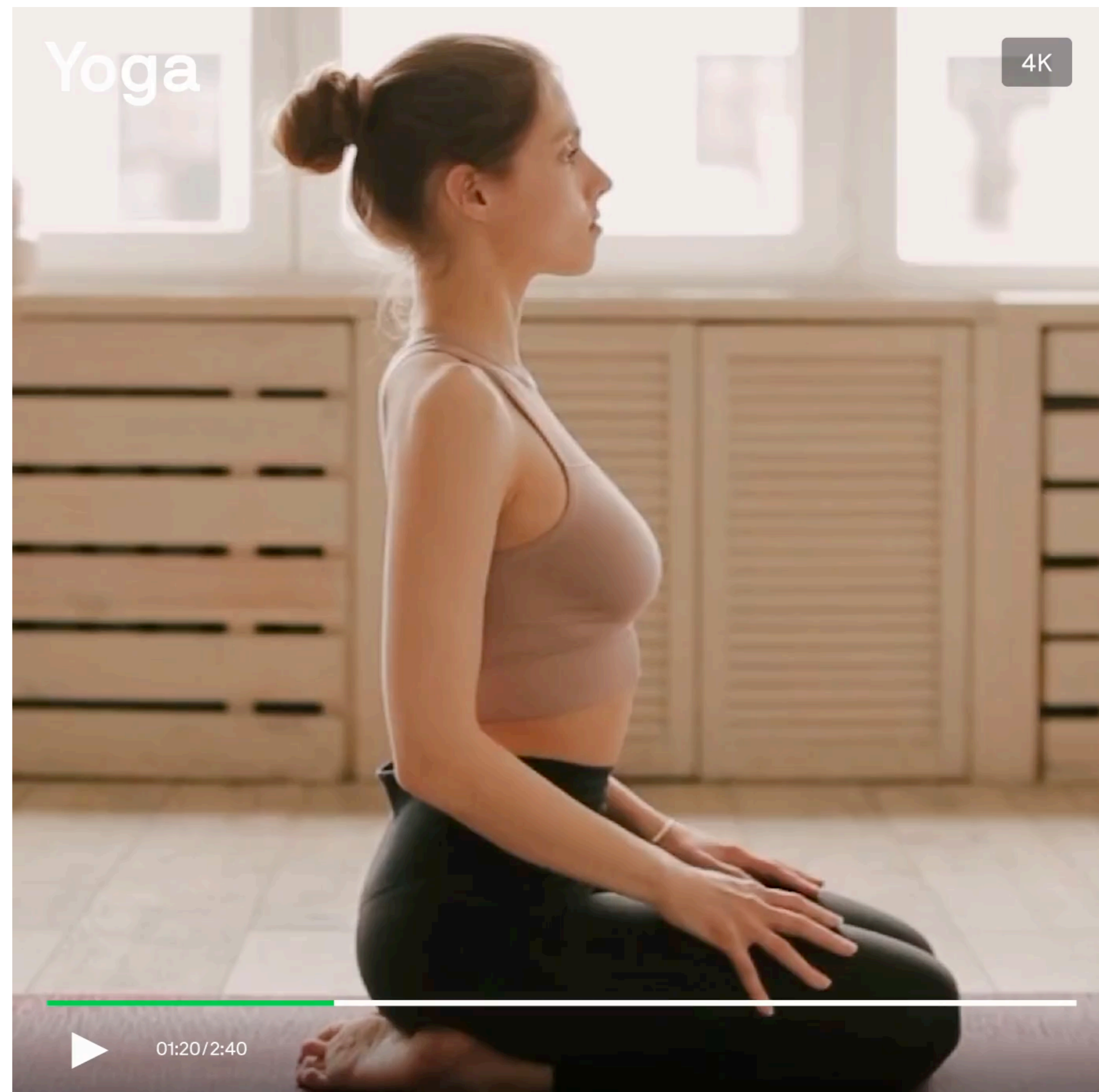

## Keyboard Accessibility

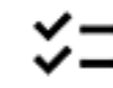

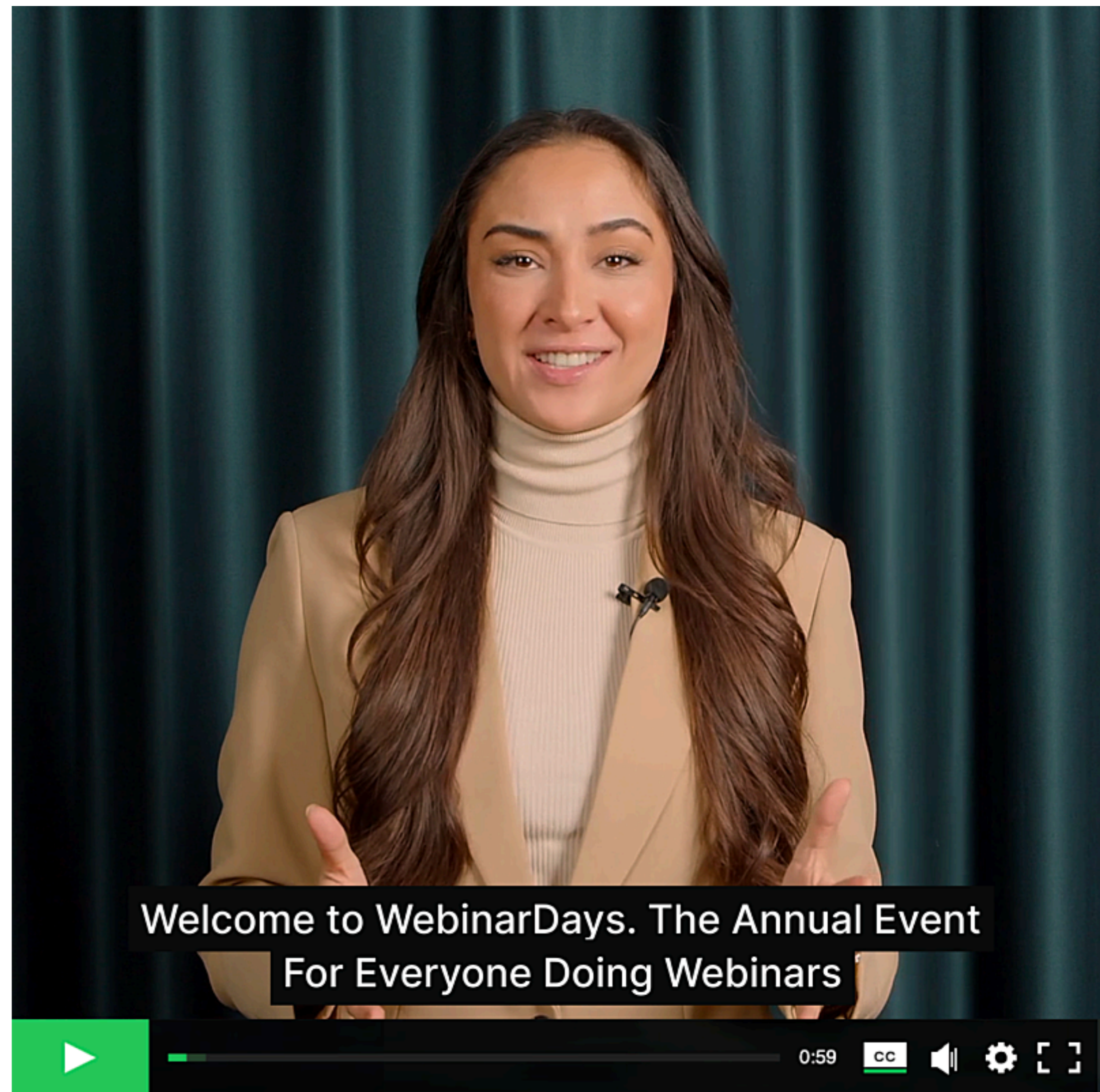

# Transcriptions

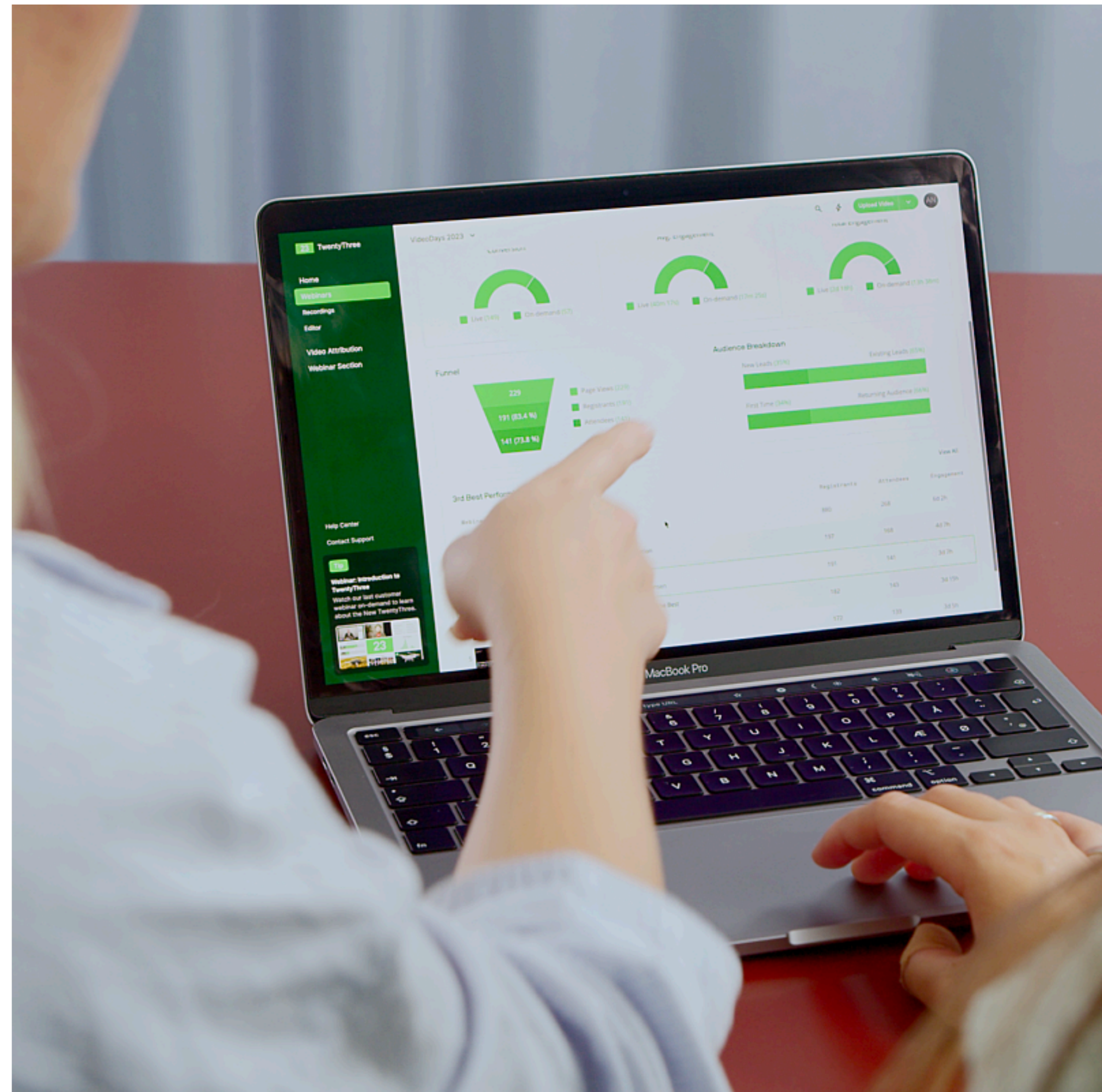
